# ANNUAL BUDGET HEARING

- New York State Education Department requires that it be held not earlier than 14 days and not later than 7 days before the annual budget vote.
- Provides district residents with an overview of the proposed spending plan in the required 3 part (Administrative, Program and Capital) format.
- Impact of Tax Levy Limit on the 2020-2021 school budget.
- Informs residents of what they will be voting on.
- The District's opportunity to keep taxpayers informed of changes that impact the school budget.

### INFLUENCING FACTORS FACING MENANDS

- Capital Project
  - Increased expenditure
  - Offset by increased state building aid
- Transportation
  - Increased enrollment & out of district placements
  - Unpredictability of McKinney Vento transportation costs
  - Approval of new multi-year contracts
    - Offset by increased transportation aid in subsequent years
    - Allows us to budget more accurately for in the long term

## WHY THIS YEAR IS DIFFERENT

#### COVID-19

 Subsequent approved NYS Budget reduced Foundation Aid, resulting in no increase, but instead flat aid moving into next year.

Initial Aid Figure	\$1,588,994
Revised Aid Figure	\$1,566,234
Reduction (Foundation Aid)	\$22,760

- The approved state budget also allowed for "take backs" throughout the fiscal year: the Governor has very publicly stated that without additional Federal funds Education will take a hit.
- Executive Order 202.26 mandated the date and manner in which votes are to be conducted
  - Time does not allow for a revote we would go right to contingency

## WHAT ARE YOU VOTING ON?

- A school budget that is within the tax levy limit of 3.36% or \$234,917
- A budget that not only maintains but enhances programs and opportunities for the children of our community.
- The budget requires a simple majority to pass, 50% + 1 yes votes.
- One Seat on the Board of Education: Bill Nevins
  - Bill is the current Vice President of the board, with longstanding ties to the community. He has triplets that attend Menands School. His tenure on the board has been focused on balancing a budget by offering the most opportunity for children while respecting taxpayers. As a business owner he provides meaningful contributions to the board. He wants the children of Menands School to continue to have access to the highest level of education.


Menands Library Budget: \$142,007

- One Seat on the Library Board: Diana Praus
  - Diana has been a Menands resident for over 30 years, and is a retired educator. She and her husband are avid readers with great appreciation of the Menands Library. Form her perspective, the library represents a key component of village life, and as such she is a staunch supporter.

# **VOTING DURING COVID -19**

- Who Can Vote
  - Eligible voters are US citizens, 18 years or older, residing in the district for at least 30 days prior to the vote
- How To Vote
  - Per Executive Order, all votes must be cast by absentee ballot
  - Voters registered with Albany County were mailed an absentee ballot with a prepaid return envelope
  - All ballots must be received in the district office no later than 5 PM on June 9, 2020

# WHAT HAPPENS IF VOTERS DO NOT APPROVE THE PROPOSED BUDGET ON JUNE 9, 2020?

- The district would go directly to a contingency budget.
- That would require a 0% tax increase, and would mean an additional reduction of \$234,917 from the current proposed budget.
  - This level of reduction could not be achieved with things, it would impact people and program.
  - There are requirements under contingency that limit the choice we have around the reductions
- Coupled with state aid takebacks, this would impact offerings programs and opportunities, simply put it would be catastrophic and detrimental to . . .
