SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. The components of our plan provide that. In particular the funds will be used to purchase PPE, as well as to cover the salary costs of employees tasked with implemnting health and safety protocols; these positions include additional cafetria staff to ensure distancing and safety precautions during school breaksfast and lunch when students would be unmasked, as well as a monitor tasked with assesing entrants and vistors to the building as well as student movement throughout the building during the day, the funding will also be used to secure a building substitue to cover staff absences—reducing the risk of exposure by having multiple individuals in that role.

Each student participating in the summer program will be assessed using pre and post tests to measure early literacy skills and subsequent growth. Additionally fluency will be assed pre and post through the use of running records. Similarly, math fact fluency and growth across the four operations will be assessed using pre and post tests. Three times annually students are assessed in ELA and math using NWEA, the needs identified will impact the targeted instruction and the benchmarking done three times annually will assess growth, as well as inform future instruction. Additionally the placement test in IXL will determine individualized and targeted interventions.

The plan also includes the use of funds to address learning loss of students during the pandemic, and assist those who have been remote with a safe return to school, including not only their academic, but social emotional needs as well. The funds dedicated to learning loss include the salary of staff for summer programming, the addition of an AIS instructor with a focus on mathematics, the purchase of research based best practice programs (Responsive Classroom/FLY 5, EnVision Math & Wilson Reading), materials and professional development, and lastly a building substitute to accommodate the needed release time for Professional Development.

To address the academic impact of loss of instruction the funds will respond to the academic impact of COVID through the implementation of an additional math AIS instructor, as math was a content particularly challenging to instruct in a COVID environment. The position will allow for the assessments of individual student needs in this area and the development of target remediation and intervention. In addition, the En-Vision math training will provide research based best practice professional development for all instructor of math to best be able to meet the needs of their students as it relates to math. The summer school program will provide both math and language rich opportunities throughout the summer, particularly targeted initially to students who were remote for all or part of the pandemic (disproportionately impacted), and beyond that targeted to to students from low income families, students of color, children with disabilities, and students experiencing homelessness.

The social emotional impact will be addressed specifically through the Responsive Classroom Training being provided, which will benefit all students social emotional well being, and in particular our needlest students, faced with the greatest challenges and most impacted by COVID-19.
